Rules & Regulations

1. ROYAL OAK OPEN - TREASURE HUNT 2011 is a Motoring Treasure Hunt lasting for about 6 hours within Klang Valley.
2. Entries are open to all REGULARS OF ROYAL OAK PUB AND RESTAURANT AND MEMBERS OF THE PUBLIC.
3. Entry forms must be fully completed and the indemnity declaration duly signed by all participants in the team. Only official entry forms will be accepted. Fees must be fully paid by 21st April 2011 before the application can be officially accepted and processed.
4. Participants are required to follow a pre-determined route and answer cryptic question. There will be 'treasure' question in which participants will have to procure specific 'items'. All treasure 'items' submitted belongs to the organizer. All answer sheet & "treasures" are to be submitted to the officials at the finish line (Finish Control) by the stipulated time. "Treasures" are to be properly labeled and placed in plastic bag provided.
5. The organizers reserve the right to accept a minimum of two persons (Driver & Navigator/s) and a maximum of four persons in any single vehicle.
6. Competition numbers and various car stickers provided by the Organizer must be placed on participating vehicle a directed by the Organizer, and these must remain on the vehicle throughout the Hunt. No other form of advertising other than those provided by the Organizer shall be permitted.
7. Participants are required to comply with the dress code for the event as determined by the Organizer.
8. The decision of awarding prizes and points by the judges will be final.
9. Rights of the Organizers:

(a)	Right to refuse any entry
(b)	Abandon, cancel or postpone the event without due notice in the event of bona fide unforeseen circumstances.
(c)	Exclude any person or vehicle appearing, upon examination to be not qualified to take part in the event.
(d)	Exclude any participant deemed unfit by reason of health, disability or being under the influence of alcohol or drugs.
(e)	Disqualify any participant who carries additional passengers not included in the Entry and Declaration Forms.
(f)	Disqualify if you loose your answer sheet.
10. It is mandatory for the driver and all passengers to have their safety belts fastened.
11. Drivers must have in force a valid driver's license and a Motor Vehicles (Third Party Risks) Rules 1959 (Malaya) Insurance policy covering them against third party liability.
12. The participants will adhere to all rules and regulations of the Traffic & Government.

13. No assistance is to be expected from the organizers. Participants are responsible for ensuring that their vehicles are adequately provided with fuel, oil, water etc.
14. Under no circumstances will any protest be entertained. Results and decisions made by the Clerk of the Course and the Organizing Committee shall be final and binding.
15. Participants are to note that the rules and regulations are applicable throughout the ROYAL OAK OPEN TREASURE HUNT 2011
16. The Organizer shall be entitled to use any materials derived from the event in any form or for any purpose that the Organizer deems fit.

We hereby declare that the driver possesses a valid driving license and has the necessary competence for this Event and will abide with the rules and regulations of this Event including all subsequent amendments, variations or modifications.

We hereby declare that the vehicle to be used in this Event is at least covered by a third party motor vehicle insurance in accordance with the Motor Vehicle Insurance (Third Party Risks) Rules 1959, which insurance is valid for the purpose of this Event.
